TRANSPARENCY NOTIFICATIONS

1. SUMMARY OF THE NOTIFICATIONS

Retail Estates NV/SA announces having received three transparency notifications from BlackRock Inc. on respectively 29 June, 30 June and 1 July 2026:

- (i) The first notification concerns a notification dated 26 June 2026 in which, with regard to voting securities or voting rights, an undershooting of the lowest threshold of 3% is reported on 25 June 2026. About Retail Estates NV/SA

The Belgian public real estate investment trust Retail Estates NV/SA (Euronext Brussels: RET) is a niche player specialised in making out-of town retail properties located on the periphery of residential areas or along main access roads to urban centres available to users. Retail Estates NV/SA acquires these real estate properties from third parties or builds and commercialises retail buildings for its own account. A typical retail building has an average area of 1,000 m² in Belgium and 1,500 m² in the Netherlands.

As of 31 March 2026, Retail Estates NV/SA has 1,006 rental units in its portfolio with a total retail area of 1,191,234 m², spread over Belgium and the Netherlands. The occupancy rate of the entire portfolio was 97.82% on 31 March 2026. The fair value of the consolidated real estate portfolio of Retail Estates NV/SA on 31 March 2026 is estimated at € 2,101.66 million by independent real estate experts.

Retail Estates NV/SA is listed on Euronext Brussels and Euronext Amsterdam and is registered as a public regulated real estate company.
